

FIRST MODIFICATION TO UNITED HEALTHCARE SERVICES, INC. HEALTH PLAN AND ADMINISTRATIVE SERVICES CONTRACT - FUNCTIONAL AREA 2 – EXCLUSIVE PROVIDER ORGANIZATION (EPO)

THIS FIRST MODIFICATION AGREEMENT is made effective this 30th day of December, 2014, by and between UnitedHealthcare Services, Inc. (“Contractor”) and the State of Maryland, acting through the Department of Budget and Management (the “Department”).

WHEREAS, on August 13, 2014, the Department entered into a contract with Contractor to provide Health Plan Administration and Services – Functional Area 2 - EPO (the “Services”) pursuant to Request for Proposals for Health Plan Administration and Services (PPO, EPO, IHM), Project No. F10B3400022 issued on November 26, 2013, and all the amendments thereto issued in writing by the State (the “RFP”); and

WHEREAS, the Contract entered into on August 13, 2014, included a Minority Business Enterprise (MBE) subcontractor that has become unavailable and the Contractor desires to replace the unavailable MBE subcontractor with another MBE subcontractor and the Department and Contractor desire to modify the Contract so that Contractor can successfully continue to perform the Services.

IN CONSIDERATION of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the parties agree to modify the Contract as follows:

- 1. MBE Participation Plan.** In fulfilling its obligation to meet the MBE Contract goal of 6%, the MBE Participation Plan for the Health Plan and Administrative Services – Functional Area 2 – EPO, submitted by the Contractor on Form D-1 dated July 30, 2014, is replaced in its entirety with the revised MBE Participation Plan for the Health Plan and Administrative Services – Functional Area 2 - EPO on revised Forms D-1 and D-3, attached hereto and incorporated by reference herein.
- 2. Scope of Modification.** This First Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of this Modification, all of the terms of the Contract shall remain in full force and effect and are hereby ratified and confirmed.
