

**Second Modification To  
Statewide Language Interpretation Services Contract**

**PRIMARY CONTRACTOR:**

- Service Category I – Telephonic Interpretation Services;

**SECONDARY CONTRACTOR:**

- Service Category II – Onsite Interpretation Services; and
- Service Category III – Written Document Translation Services

**THIS SECOND MODIFICATION** (the “Modification”) is made as of July 1, 2012, by and between CORPORATE TRANSLATION SERVICES, INC., DBA CTS LANGUAGELINK (“Contractor”) and the STATE OF MARYLAND, acting through the DEPARTMENT OF BUDGET AND MANAGEMENT (the “State”).

WHEREAS, the Contractor and the State executed a contract dated June 7, 2007 for Statewide Language Interpretation Services (the “Services”), Project No. 050B7800015 which was amended by a First Modification dated May 21, 2008 (collectively, the “Contract”); and

WHEREAS, the State and Contractor desire to modify the Contract so that the Contractor can successfully continue to perform the Services.

NOW, THEREFORE, in consideration of the Recitals which are hereby made a substantive part hereof, and the mutual promises and covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the Department and Contractor hereby mutually agree to the changes below:

1. **Contract Term.** The first sentence of Section 3 of the Contract shall be amended to state that the Contractor shall provide Services for an additional three months, from July 1, 2012 through September 30, 2012, unless terminated earlier as provided in the Contract.
2. **Consideration and Payment.** Except with the written consent of the Procurement Officer, payment to the Contractor pursuant to this Contract shall not exceed **\$3,000,000.00**.
3. **Scope of Modification.** This Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of this Modification, all of the existing terms of the Contract shall remain in full force and effect and shall apply to this Modification.


