PRIMARY CONTRACTOR: SCHREIBER TRANSLATIONS, INC.**

Service Category III– Written Document Language Translation

This Third Modification is made this 26th day of October, 2009, by and between the STATE OF MARYLAND, DEPARTMENT OF BUDGET AND MANAGEMENT, DIVISION OF PROCUREMENT POLICY AND ADMINISTRATION (the “Department”) and SCHREIBER TRANSLATIONS, INC. (hereinafter referred to “Contractor”).

WHEREAS, on June 25, 2007, the Department entered into a contract to provide Written Document Language Translation Services for Service Category III (the “Services”) with Contractor (the “Contract”) pursuant to Request For Proposals for Statewide Language Interpretation Services, Project No. 050B7800015, dated October 17, 2006, and all amendments thereto issued in writing by the State .

WHEREAS, on May 2, 2008, the Department and Contractor executed a First Modification to the Contract (“Modification No. 1”); and

WHEREAS, on February 13, 2009, the Department and Contractor executed a Second Modification to the Contract (“Modification No. 2”); and

WHEREAS, the Department and Contractor desire to further modify the Contract so that Contractor can successfully continue to perform the Services.

NOW, THEREFORE, in consideration of the Recitals which are hereby made a substantive part hereof, and the mutual promises and covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the Department and Contractor hereby mutually agree to the changes below.

- 1. Consideration and Payment (§4.1).** Except with the written consent of the Procurement Officer, payment to the Contractor pursuant to this Contract shall not exceed \$1,500,000.00.
- 2. Scope of Modification.** This Third Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of Modification No. 1, Modification No. 2, and this Third Modification, all of the terms of the Contract shall remain in full force and effect and are hereby ratified and confirmed.
